**CONTEST PERIOD** The contest begins on December 12, 2026, noon ET and ends on January 26, 2026, noon ET. ("Sweepstakes Period"). All entries (submissions) must be received on or before the time stated during that submission period. Administrator reserves the right to extend or shorten the contest at their sole discretion.

**HOW TO ENTER** You can enter the Rep Your Squad Challenge by creating a 30-60 second video that will be uploaded to the contest website and submitted by Wednesday December 10, 2025, at 5:00 pm. After submitting the required information, the entrant will receive one (1) video entry per team. Voting will begin on Friday December 12, 2025, at noon until Saturday January 31, 2026, at 11:59 PM EST.

**WINNER SELECTION** All eligible entries received during the Submission Period will be gathered into a database at the end of the Submission Period. A winner will be chosen based on the top number of votes received. The winners will be announced on or about Friday February 6, 2026. Announcements and instructions for the prize will be sent to the e-mail address of the cheer team or band representative for each institution. Each representative is responsible for monitoring his/her email account for prize notification and receipt or other communications related to this sweepstakes. If a potential prize winner cannot be reached by

Administrator within fifteen (15) days, using the contact information provided at the time of entry, or if the prize is returned as undeliverable, that potential prize winner shall forfeit the prize. Upon the request of the Sponsor or Event Organizer, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form and IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner will be disqualified. Prizes may not be awarded if an insufficient number of eligible entries are received.
